RESOLUTION STATING THE TANGIPAHOA PARISH COUNCIL-PARISH PRESIDENT GOVERNMENT'S ENDORSEMENT INTRALOX, LLC (Extension of Project # 20120965) TO PARTICIPATE IN THE BENEFITS OF THE LOUISIANA QUALITY JOBS PROGRAM

WHEREAS, the Louisiana Quality Jobs Act of 2012, Act 387 was enacted by the 2012 Louisiana State Legislature

WHEREAS, the Louisiana Quality Jobs Program offers significant incentives for economic development to some of the most distressed area in Tangipahoa Parish; and

WHEREAS, the Louisiana Department of Economic development designated Census Tract 9540 Block Group 3 in Tangipahoa Parish as "Quality Jobs or Economic Development Zone" eligible based on enabling legislation (R.S.47:305.66 and 337.9 (D)(31)); and

WHEREAS, the Tangipahoa Parish Council-Parish President Government states this endorsement is in agreement with the Overall Economic Development Plan for the Parish of Tangipahoa; and

WHEREAS, in accordance with the Louisiana Quality Jobs Program requirements, the Parish of Tangipahoa agrees to:

- 1) Participate in the Quality Jobs program
- 2) To provide assistance to the Louisiana Department of Economic Development in certifying employers to be eligible for the benefits of this program. This would include verification of the location of the business, number of employees and other verification that would have to be made at the local level
- 3) To REFUND applicable* local sales taxes on the purchase of the material used in the construction of a building, or any addition or improvement thereon, for housing any legitimate business enterprise, and machinery and equipment used in that enterprise. This tax refund would be on materials, construction and equipment purchased for this project and used by that business
- 4) To keep the Department informed whenever changes occur within the zone, i.e., an establishment goes out of business, is destroyed by fire, flood, etc., new development codes that may affect the zone.

BE IT RESOLVED by the Tangipahoa Parish Council in due, regular and legal session convened this 14th day of August, 2017 that INTRALOX, LLC and their expansion project, Extend PROJECT NO. 20120965 are endorsed to participate in the Louisiana Quality Jobs Program.

Requesting Amendment of Hydraulic Design Guidelines for Bridges on Interstate 12 in Tangipahoa Parish

Whereas, the Louisiana Department of Transportation & Development ("LaDOTD") 2011 Hydraulics Manual specifies a "Design Storm Frequency" of fifty years (50 yrs) for Interstates (RE: LaDOTD 2011 Hydraulics Manual Table 1.3-1), and

Whereas, NOAA Atlas 14, Volume 9, indicates a "50 year" rainfall event for Tangipahoa Parish to be 4.27 inches (60 minute duration) and 10.6 inches (24 hour duration), and

Whereas, NOAA rainfall records indicate 24 hour rainfalls in excess of 10" occurred in Tangipahoa Parish on at least three (3) separate dates in March, 2016, and August, 2016, and

Whereas, the widening of Interstate 12 traversing Tangipahoa Parish is approaching the engineering/hydraulic design stage, presumably utilizing the "50 year Rainfall Design" criteria for bridges on Interstate 12.

NOW, THEREFORE, BE IT RESOLVED by the Tangipahoa Parish Council meeting in regular session this the 14th Day of August, that the LaDOTD revise its design criteria from the current "50 year Rainfall Design" to a "Minimum 100 year rainfall design" to reduce and/or eliminate backwater effects of the new bridges to be widened along Interstate 12 in Tangipahoa Parish.

A resolution authorizing Sewerage District No. 1 of the Parish of Tangipahoa, State of Louisiana to proceed with the issuance, sale and delivery of its not to exceed \$14,000,000 Revenue and/or Refunding Bonds, in one or more series. WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, as amended, and La. R.S. 33:1415, it is now the desire of the Parish Council, as the governing authority of the Parish of Tangipahoa, State of Louisiana (the "Parish") to approve the issuance and delivery of not to exceed \$14,000,000 Revenue and/or Refunding Bonds, in one or more series (the "Bonds"), by Sewerage District No. 1 of the Parish of Tangipahoa, State of Louisiana (the "District"), the proceeds of which will be used by the District to acquire, construct, extend and improve the sewerage system owned by and located within the District (the "System") and, if economically advantageous, refunding certain existing debt.

NOW THEREFORE, BE IT RESOLVED by the Parish Council, as the governing authority of the Parish:

SECTION 1. That, in compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, as amended, and La. R.S. 33:1415, and in accordance with the request of the Board of Supervisors of the District, the Parish Council approves the issuance and delivery of not to exceed \$14,000,000 Revenue and/or Refunding Bonds of the District, in one or more series. The Bonds shall bear interest at a fixed rate or rates not exceeding six percent (6.00%) per annum, shall mature no later than thirty (30) years from the date of issuance thereof, and shall be issued under the authority of Chapter 14-A and Section 1430 of Title 39 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority, or such other authority as may be determined by resolution of the District at the time of the issuance of the Bonds.

SECTION 2. The Parish President, the Council Chairman and the Council Clerk are hereby authorized and directed to do any and all things necessary and incidental to carry out the provisions of this resolution and to assist the District in carrying out its functions in connection with the financing.

BE IT RESOLVED that the Parish President and/or outside counsel Glen Galbraith are authorized to request an opinion from the Attorney General on (1) whether Tangipahoa Parish may pay post-retirement benefits (such as health insurance benefits) of Tangipahoa Parish School System retirees who were assigned to jobs paid for by federal workforce development grants; and (2) whether Tangipahoa Parish may pay those benefits out of grant funds.
