T.P. ORDINANCE No. 18-11

AN ORDINANCE TO REQUIRE ANY MUNICIPALITY, PARISH, WATER DISTRICT, OR PRIVATE WATER COMPANY OPERATING A WATER SYSTEM SERVING CUSTOMERS IN THE AREA SERVED BY SEWERAGE DISTRICT NO. 1 FOR TANGIPAHOA PARISH TO COLLECT SERVICE CHARGES IMPOSED BY THE SEWERAGE DISTRICT ON SERVED CUSTOMERS AND TO AUTHORIZE THE SAME TO DISCONNECT WATER SERVICES DUE TO FAILURE TO TIMELY PAY SERVICE CHARGES IMPOSED BY THE SEWERAGE DISTRICT. FURTHERMORE, EACH MUNICIPALITY, PARISH, WATER DISTRICT, OR PRIVATE WATER COMPANY REQUIRED TO COLLECT THIS SERVICE CHARGE SHALL BE LIABLE FOR DAMAGES SUFFERED BY THE SEWERAGE DISTRICT AS A RESULT OF FAILURE TO REMIT CHARGES COLLECTED THAT ARE OWED TO THE SEWERAGE DISTRICT.

WHEREAS, LA R.S. 4169(C), as amended, and other constitutional statutory authority, authorizes the Tangipahoa Parish Council to enact ordinances which enforce said statute requiring any municipality, parish, water district, or private water company operating a water system in an area serviced by Sewerage District No. 1 for Tangipahoa Parish to collect service charges imposed by the Sewerage District on those customers being served and to authorize those same water servicers to disconnect water services due to failure to timely pay service charges imposed by the Sewerage District. Furthermore, the above listed revised statute also gives Tangipahoa Parish Council the authority to enact an ordinance to hold each of the above referenced water service providers liable for damages suffered by the Sewerage District as a result of failure of the water service providers to remit charges collected that are owed to the Sewerage District.

WHEREAS, the Tangipahoa Parish Council now desires to create and enact such an ordinance as described hereinafter.

THEREFORE, BE IT ORDAINED by the Council of the Parish of Tangipahoa, State of Louisiana,

SECTION I:

Any municipality, parish, water district, or private water company operating a water system in an area serviced by Sewerage District No. 1 for Tangipahoa Parish shall be required to collect service charges imposed by the Sewerage District on those customers being served.

SECTION II:

Any municipality, parish, water district, or private water company operating a water system in an area serviced by Sewerage District No. 1 for Tangipahoa Parish shall be authorized to disconnect water services from any customer for failure to timely pay any service charge imposed by the Sewerage District No. 1 for Tangipahoa Parish.

SECTION III:

Any municipality, parish, water district, or private water company operating a water system in an area serviced by Sewerage District No. 1 for Tangipahoa Parish shall be held liable for any damages incurred by Sewerage District No. 1 for Tangipahoa Parish for failing to remit charges collected that are owed to the sewerage district.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

BE IT FURTHER ORDAINED that this ordinance shall become effective immediately upon adoption of the TPC and signature of the Parish President.

T.P. Ordinance No. 18-13

"AN ORDINANCE TO REVISE AND AMEND SECTION 8-1, 8-3 8-6 AND 8-9 OF CHARTER 8 OF THE TANGIPAHOA PARISH CODE OF ORDINANCES"

WHEREAS, this ordinance has been prepared at the direction of the Office of Tangipahoa, Community Development acting through its director, Bridget Bailey;

WHEREAS, Tangipahoa Parish Council President Government (the "Parish") pursuant to LA R.S. 40:1730.21, et seq., adopted the Louisiana State Uniform Construction Code (the "LSUCC") for the purpose of regulating the construction, reconstruction, alterations, repair, equipment, use and occupancy and maintenance of every building or structure or any appurtenance connected or attached to such buildings or structures within the Parish and incorporated the same into its Code of Ordinances as a part of Chapter 8 - Buildings and Building Regulations in 2007,

WHEREAS, since the adoption of the LSUCC, the LSUCC has been amended to reflect current references to the several international building code citations as those codes were revised and amended, the Tangipahoa Parish Code of Ordinances as a part of Chapter 8 Buildings and Building Regulations has not been accordingly amended to reflect the same,

WHEREAS, the Parish recognizes that the LSUCC will continue to be amended and revised, requiring the Parish to continuously amend Chapter 8 Buildings and Building Regulations to accordingly reflect current references as a part of that State law,

WHEREAS, the proposed amendments enhance the purpose of the Building and Building Regulation Ordinance as listed below:

- a) Allow the Parish to stay in compliance with State Law concerning the adoption of the building codes as approved and amended by LSUCC;
- b) Maintain reasonable standards of construction and provide for uniform performance standards including reasonable safeguards for health, safety, welfare, comfort, and security for the residents of this parish and/or those who are occupants and users of buildings within this parish;
- c) Eliminate the need to continuously and periodically amend the ordinance for future changes and modifications as per the LSUCC;
- d) Allow that Section 8-1 of Chapter 8 be prospectively amended in all respects to reflect the then current building code regulations.

THEREFORE BE IT ORDAINED by the Tangipahoa Parish Council, the legislative branch of parish government, which along with the Parish President of Tangipahoa Parish, Louisiana constitute the parish government, the said Tangipahoa Parish Council-President Government having a Home Rule form of government and acting pursuant to the authority of that Home Rule Charter which became effective on October 27, 1986 as follows:

That Section 8-1, 8-3, 8-6 and 8-9 of Chapter 8 of the Tangipahoa Parish Code of Ordinances be revised, amended and re-enacted to read as follows:

Sec. 8-1. - Building codes adopted by reference.

Pursuant to LA R.S. 40:1730.21 et seq., the Tangipahoa Parish Council President Government herein and hereby adopts as its parish law and shall enforce the provisions and minimum required standards of the hereinafter described building code for the purpose of regulating the construction, alteration, repair, equipment installation, use and occupancy and the maintenance of every building or structure or any appurtenance appurtenances connected or attached to each such building or structure located within the unincorporated areas of Tangipahoa Parish, Louisiana in accordance with and as revised, adopted and amended by and in the Louisiana State Uniform Construction Code (LSUCC).

Sec. 8-3. - Licensure and registration and residential and commercial buildings.

- (a) All general contractors, together with electrical and mechanical subcontractors, when contracting in an amount in excess of \$10,000.00, must be licensed by the State of Louisiana.
- (b) All plumbers must be licensed by the State of Louisiana.
- (c) All general contractor's residential contractors and subcontractors must be registered with the Tangipahoa Parish building official before he/she can bid, enter into any contract and/or perform work. All contractors - And must submit proof of state licensure(s) at time of registration.

Sec. 8-6. - Application for license.

Each person who is required to obtain a license under the provisions of this part shall make application in writing to the building official on forms provided by him. The application shall be signed by the applicant under oath and shall contain the following information:

- (1) The full name, sex and age of the applicant.
- (2) Residential address at the time of application.
- (3) The name under which the business is to be conducted.
- (4) Location of place of business for which the license is sought.
- (5) Type of license being sought.
- (6) Residential or cellular telephone number.

Sec. 8-9. - License fees and renewals.

- (a) Licenses issued shall expire at midnight on December 31 of the year in which issued and may be renewed prior to their expiration, upon receipt of application and payment of the annual fee.
- (b) A license shall not be issued to anyone without first meeting the following requirements:

- (1) All bonds and insurance in force.
- (2) All installations cleared with the inspection division that have been rejected for code violations.
- (3) All State of Louisiana Contractors/Plumbing Licenses.

BE IT FURTHER ORDAINED by the Tangipahoa Parish Council that this ordinance shall take effect immediately upon the signature of the Tangipahoa Parish President.

IT IS FURTHER ORDAINED by the Tangipahoa Parish Council that this ordinance, having been duly introduced, having been the subject of a public hearing and having been passed into law thereafter be promulgated by publication of notice of its passage along with a complete copy of the ordinance in the official journal of the Tangipahoa Parish Council-President Government and after thirty (30) days from this publication, it shall take effect and be in full force and effect.

A resolution authorizing Ponchatoula Area Recreation District No. 1 of the Parish of Tangipahoa, State of Louisiana to proceed with the issuance, sale and delivery of its not to exceed \$3,500,000 Revenue Bonds, in one or more series.

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, as amended, and La. R.S. 33:1415, it is now the desire of the Parish Council of the Parish of Tangipahoa, State of Louisiana, as the governing authority of the Parish of Tangipahoa, State of Louisiana (the "Parish") to approve the issuance, sale and delivery of not to exceed \$3,500,000 Revenue Bonds, in one or more series (the "Bonds"), by Ponchatoula Area Recreation District No. 1 of the Parish of Tangipahoa, State of Louisiana (the "District"), the proceeds of which will be used by the District to (i) financing the construction and equipping of additional recreation facilities, including, but not limited to, a new multi-purpose gymnasium facility located within the District (the "Project"); (ii) fund a debt service reserve fund, if necessary; and (iii) pay the costs of issuing the Bonds.

NOW THEREFORE, BE IT RESOLVED by the Parish Council, as the governing authority of the Parish, that:
SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, as amended, and La. R.S. 33:1415, and in accordance with the request of the Board of Commissioners of the District, the Parish Council approves the issuance, sale and delivery of not to exceed

\$3,500,000 Revenue Bonds of Ponchatoula Area Recreation District No. 1 of the Parish of Tangipahoa, State of Louisiana, in one or more series. The Bonds shall bear interest at a fixed rate or rates not exceeding five and one-half percent (5.50%) per annum, shall mature no later than June 1, 2039, and shall be issued under the authority of Section 1430 of Title 39, as amended, and other constitutional and statutory authority, or such other authority as may be determined by resolution of the District at the time of the issuance of the Bonds.

SECTION 2. The Parish President, the Council Chairman and the Clerk of Council are hereby authorized and directed to do any and all things necessary and incidental to carry out the provisions of this Resolution and to assist the District in carrying out its functions in connection with the financing.
