1. **Redistricting Matters - Strategic Demographics, LLC**  
Dan Garrett presented Redistricting Plan A to the Council. After a lengthy discussion and concerns regarding some precincts moved in District 4 and District 5, an amendment was agreed to be made and presented on November 14, 2022.  
Mr. Garrett presented Redistricting Plan B (minority plan). After a brief discussion the plan was deemed unfavorable by the council.
