## SPECIFICATIONS

### CLAY:

Material must conform to La. DOTD Specification 203.06 (a) "usable soils". This specification requires that usable soil have a plasticity index of 20 or less, an organic content of less than 5 percent and a maximum silt content of 60 percent.

### GRAVEL:

Material must conform to La. DOTD Specifications 1003:02 (b) (1) "uncrushed coarse aggregate". This specification requires that the material must have less than 5 percent total clay lumps and friable particals. This material must also conform to the following gradations:

<u>U.S. Sieve</u>	<u>Percent Passing</u>
2"	90-100
1"	35-80
No. 4	0-6
No 200	0-1

### DISTANCE:

Six (.06) cents per mile will be added to the per yard bid price to determine the low bidder. Mileage will be based on distance from yard to pit.
